Minutes of the meeting of the Departmental Research Committee of Biochemistry held on 09/11/2023.


A meeting of Departmental Research Committee of Biochemistry was held on 09/11/2023 in the Committee room of the Department. The following members were present:



At the outset, the chairperson welcomed the members and thereafter the agenda of the meeting was taken up for discussion. The following recommendations were made.


1. Three synopses were placed before DRC for review and discussion. The synopsis submitted by Ms Munaza Rafiq and Mr Idris Ali were thoroughly discussed by DRC members with the concerned supervisors and research scholars. The scholars were directed to incorporate necessary corrections/modifications and resubmit their synopsis within 4 days.
2. The synopsis submitted by Mr Athar-ul-Islam was discussed. The DRC was not convinced with the work proposed in the synopsis and therefore returned it to the concerned supervisor for necessary clarifications.
3. The applications submitted by Ms Qudsia Fatima for special extension and Re-registration was returned to the Supervisor of the candidate for clarification. It was noted by the DRC that the active registration period of the candidate has expired in July 2022 and the candidate has not applied for re-registration in advance.

It was also recommended that in case the candidate is availing any fellowship the supervisor shall take up the matter with concerned funding agency for leave rules and regulations.


The meeting ended with the vote of thanks.
